Subject: Communication to Shareholders for TDS deduction

We are pleased to inform you that the Board of Directors at their Meeting held on 26th May, 2025 has recommended a Dividend of Rs. 15/- per Equity Share of Rs.10/- each (150%) for the Financial Year ended 31st March, 2025 and the said Dividend will be payable post approval of the shareholders at the ensuing Annual General Meeting ("AGM") of the Company.
