- (b) The Investment of the Company has exceeded the limits as per the Concentration of Credit/Investment norms provided in paragraph 18 of Non- Banking Financial (Non Deposit Accepting or Holding) Companies prudential norms (Reserve Bank) Directions, 2007 (as amended) for which the Company has applied to the Reserve Bank of India seeking exemption from complying with the aforesaid norms upto 31st March 2015. Also the Company has applied for its conversion from Non Banking Financial Company to Core Investment Company. The auditors have referred the above matters in their audit report for the year ended 31st March 2014 and limited review report for the quarter ended 30th June 2014.
- 3 The previous period figures have been re-grouped, wherever necessary, to conform to the current period figures.
- 4 The company has only one business segment and as such segment reporting as required by Accounting Standard 17 is not applicable.
- 5 There are no exceptional/extra ordinary items during the above period.
